- Present information and communication systems
- Provide services
- Advise customers in the selection of equipment and systems
- Conclude sales and service contracts and assist in marketing measures
- Analyse customer requirements
- Design information systems according due consideration to business aspects
- Install and commission information and communications systems, telecommunications installations including terminal devices, computer networks, accompanying power supply and lighting
- Install and configure applications software
- Programme applications and test systems
- Set up and install information and communications systems including accessories and furniture according due consideration to ergonomic and organisational aspects
- Advise customers in relation to deployment and administration of systems, data security, data protection and ergonomic aspects
- Analyse errors in information and communications systems and repair equipment and systems
- Carry out service including operating advice, support users, provide user training and administer systems
- Under the provisions of the Prevention of Accidents Regulations, information electronics technicians are deemed to be skilled electrical and electronic engineering workers

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Information electronics technicians plan and install information technology and telecommunications systems providing service from a single source. They work at repair companies or in sales. Typical fields of activity are office technology and audio-visual media technology.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3,5 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
