- Design habitats of wild animals and hunting grounds
- Manage stocks of game sustainable
- Collect data on stocks of game and habitats, Implement measures for protecting game and hunting
- Organise hunting operations and hunts
- Carry hunting weapons and use such weapons in a way appropriate to animal protection
- Keep, feed and use hunting dogs
- Assess and market game which has been killed
- Carry out animal protection measures and measures for the protection of species according due consideration to ecological circumstances and sustainability
- Organise public relations measures and events
- Plan and document work, determine work steps and check and evaluate work results
- Carry out work autonomously or as part of a team with due consideration to general operational conditions, environmental protection, health and safety at work and health protection

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
