### 3. PROFILE OF SKILLS AND COMPETENCES

- Carry out upholstery and covering work
- Produce and fit roof covers and tarpaulins
- Design, produce and fit interior coverings
- Select materials and accessories on the basis of properties, intended use and customer requirements
- Evaluate leather according to type, origin, tanning type and histological aspects
- Process and modify leather, synthetic leather, textile surface coverings, plastics and metals
- Plan production steps for the manufacture of upholstery products, stipulate and document processing techniques
- Use and maintain tools, devices, machines and technical equipment
- Cut or stamp work and auxiliary materials in the correct manner according to the type of material
- Carry out different types of sewing and seaming work both manually and by machine
- Use a range of different upholstery techniques
- Fit fastening and closing elements
- Mount finished parts and add accessories
- Carry out quality assurance measures
- Accord due consideration to the basic principles of safety, health and safety at work and environmental protection

### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Saddlers specialising in vehicle upholstery mainly work at specialist saddling companies within the craft trades sector, at vehicle upholstery companies, at repair workshops specialising in the restoration of vintage cars or at companies manufacturing leather furnishings, lorry tarpaulins or sports equipment featuring leather upholstery. They may also find employment at supplier companies in the motor vehicles sector.

| <p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b><br/>       Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
