- Design and manufacture bobbin lace
- Use a range of bobbin lace making techniques
- Develop and create designs
- Execute experimental works in lace
- Plan and prepare work processes
- Use and combine materials in accordance with their intended purpose and cost-effectiveness
- Prepare technical documentation
- Handle equipment and tools
- Execute corners and round edges
- Create edge starts and finishes, fit connecting elements and decorations
- Join and assemble lace
- Repair bobbin lace
- Sell and present bobbin lace
- Advise customers
- Assess quality and carry out quality assurance measures
- Accord due consideration to the basic principles of health and safety at work, health and environmental protection

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Textile designers (craft trades) specialising in bobbin lace find employment in workshops, studios and companies. Possible areas of work may include fashion studios, therapeutic institutions or theatre workshops and museums. Later career progression often leads to self-employment.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body: <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<b>Additional information</b>  <b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education. <b>Duration of training:</b> 3 years. <b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
