3. PROFILE OF SKILLS AND COMPETENCES

- Build, inspect and maintain structures in and alongside waterways
- Construct, inspect and maintain waterfront protection and maintenance paths
- Carry out measures for the management and development of waterways
- Build inspect and maintain structures for coastal and island protection
- Carry out construction monitoring tasks
- Carry out measures for the maintenance and inspection of waterway beds and mark and secure shipping channels and safe passages
- Take hydrographical measurements, carry out flood protection and flood and ice defence measures
- Operate floating vehicles and floating equipment
- Operate and maintain dams, reservoirs and retention basins
- Measure dimensions and draw up documents
- Erect and dismantle scaffolding, use and maintain transport equipment
- Plan, manage and prepare operational processes and coordinate such processes with other trades
- Work in a team
- Conduct discussions with contracting companies, check quality of work for any errors in execution, document works, carry out quality assurance measures
- Record materials and time used and invoice for services provided
- Initiate safety, health and safety at work and environmental protection measures

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Hydraulic technicians work at facilities, structures and other objects located near or in waterways. They also work on floating vehicles and in workshops.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
