## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>The advanced training qualification is obtained by passing an examination before the competent body specified under Section 5. In order to be admitted to the examination, candidates must provide evidence of one of the following.</p> <ol style="list-style-type: none"> <li>1. Successful completion of the examination leading to the qualification of Certified Professional Specialist for the Notarial Practice</li> <li>2. Successful completion of the final examination leading to the qualification of notary assistant or to the qualification of legal and notary assistant</li> <li>3. Successful completion of the final examination leading to the qualification of legal assistant or to the qualification of patent legal assistant and at least one year of practical professional experience following the respective vocational education and training programme</li> <li>4. Successful completion of the final examination in another recognised training occupation with a duration of vocational education and training of three years and at least two years of practical professional experience following this vocational education and training programme</li> <li>5. Successful completion of the final examination in a recognised training occupation with a duration of vocational education and training of at two years and at least three years of practical professional experience following this vocational education and training programme</li> <li>6. The acquisition of at least 90 credit points in accordance with the European Credit Transfer and Accumulation System in a related course of higher education study followed by at least two years of practical professional experience or</li> <li>7. A period of practical professional experience of at least five years</li> </ol> <p>Practical professional experience pursuant to Paragraph 1 Nos. 3 to 7 must exhibit significant relevance to the tasks stated in § 1 Paragraph 3. Duration and content of the practical professional experience must be documented in a suitable manner.</p>
