### 6. OFFICIALLY RECOGNIZED WAYS OF ACQUIRING THE CERTIFICATE

The advanced vocational education and training certificate is obtained by passing an examination before the competent body specified under 5. Those who provide evidence of the following may be admitted to the examination:

- 1. Successful completion of the final examination in the recognized training occupations of gardener, forest manager or farmer or
- 2. successful completion of the final examination in another recognized training occupation and at least three years of relevant professional practical experience following this vocational education and training, or
- 3. a period of occupational practice of at least five years.

### Additional information

Acquisition of the competences to be demonstrated in the final examination (employability skills) is usually the result of many years of professional practice and takes place within the scope of education and training measures. Training measures are offered to enable candidates to prepare for the examination. The duration and contents of such training measures are geared towards the differentiated functional and management tasks.

Translations of the certificate can be obtained from the competent bodies for vocational education and training in agriculture.
