3. PROFILE OF SKILLS AND COMPETENCES

- Supervise teams, promote communication, cooperation and environmental awareness, ensure compliance with security regulations, cooperate in staff selection, deployment, management and development activities and decision-making, assume responsibility for training, ensure observance of quality standards and of labour and social law in the area of responsibility
- Organize and design corporate processes in a forward-looking, conceptual and sustainable manner, analyse the market, optimize costs, plan investments, ensure the functioning of systems and compliance with labour, environmental and health protection legislation and provide for the implementation of media and event management law in operations
- Acquire contracts, draw up tenders, support and advise customers, observe basic contract law, settle copyright and exploitation issues, obtain permits, identify and calculate demand and cost and effort, design projects, define the workflow, plan staff assignment, carry out risk analyses
- Secure the procurement, transport, storage, assembly and disassembly of material, assume responsibility for the installation and putting into operation of production, transmission and post-production systems, ensure compliance with work, health and fire safety regulations, monitor the budget, provide for the prevention of danger and develop strategies for accident management, provide instruction and training for internal and external staff, realize data management and quality assurance
- Present productions and projects and hand them over to the client, recalculate costs and renegotiate projects, prepare accounting, ensure data management, processing and archiving, supervise maintenance of equipment, organize settlement of claims, draw up final reports and project documentation, safeguard copyright and exploitation and privacy rights.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Certified senior audiovisual media production specialists work with public or private broadcasters, film production firms or advertising businesses. They fulfil functions in staff and business management. In the area of project management, they organize and prepare audiovisual productions and implement, steer, supervise and control them, and provide instruction for staff.

6. OFFICIALLY RECOGNIZED WAYS OF ACQUIRING THE CERTIFICATE
<p>The certificate is acquired through passing the examination administered by the body mentioned in section 5 above. Before sitting the examination, candidates must furnish proof of</p> <ol style="list-style-type: none"> 1. Successful completion of training for the recognized occupation of audiovisual media designer (<i>Mediengestalter/Mediengestalterin Bild und Ton</i>) or film and video editor (<i>Film- und Videoeditor/Film- und Videoeditorin</i>), followed by at least one year of relevant practical work or 2. Successful completion of training for another recognized technical occupation, followed by at least two years of relevant practical work or 3. At least five years of relevant practical work or 4. Relevant skills and competences.
Additional information <p>The skills and competences of which proof is to be furnished in the further training examination are usually acquired during many years of practical work and within the framework of education measures. Courses are offered in preparation for the examination; their duration and content are geared to the different specialist and managerial tasks.</p> <p>The successful candidate passing the examination has acquired the qualifications required to provide training within the meaning of Section 30(5) of the Vocational Training Act.</p> <p>Translations of the certificate can be obtained from the body mentioned in section 5 above.</p>
