3. PROFILE OF SKILLS AND COMPETENCES

- · Act independently in conducting work on the basis of technical documentation or according to instructions
- Set up construction sites
- · Plan work steps and take measures to secure the work process and to maintain health and safety at work and health protection
- Check quality of the work carried out for any errors in execution
- · Carry out final checks
- Draw up a list of materials to be used and clear the site
- · Build timber constructions for roof frames, half-timbered walls and thermal insulation systems
- · Cover roof and wall surfaces with slate, roof slabs, shingles, corrugated sheeting roof tiles and roof stones
- · Seal roof, wall and floor surfaces against ground moisture and other non-penetrating moisture using synthetics and bituminous materials
- · Apply coverings made of sheet metal
- · Build sub-constructions for claddings on outside walls
- · Clad external walls
- Build structures and layering systems for roof planting schemes
- Install devices to drain surface water and for the collection and conversion of energy
- · Erect lightning protective systems for exterior lightning protection
- · Repair roofs, walls and timber constructions.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
