- Plan production processes autonomously and as part of a team
- Accept analogue and digital data and prepare such data for printing plate production
- Use production data to make printing plates for various applications
- Select and use screen printing inks and substrates for the respective application
- Set up printing presses and print single and multicolour products
- Check and optimise the printing process in accordance with quality standards and the printer's copy
- Apply product and production-specific post-print processing techniques
- Carry out measuring and testing activities as part of quality management
- Set up web-fed intaglio printing presses with support from the control room
- Control inline production
- Print magazines, catalogues, wallpaper, packaging material, etc.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Printers specialising in intaglio printing mainly work at printing companies which use intaglio printing to produce printed materials. Some printers specialising in intaglio printing also work for companies in related branches and for book, newspaper and magazine publishing companies.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
