- · Support developers in the realisation of contracts, in the analysis of required functionalities and environmental technical environmental conditions and in the design of circuits
- Manufacture models and one-off products
- Select and adapt mechanical, electrical and electronic components
- · Assemble devices and systems
- Install and configure programmes
- · Test devices and systems
- Draw up device and system documentation
- · Prepare layouts and documents
- · Award and coordinate orders for the procurement of components, ancillary materials and operating equipment for the realisation of internal and external customer contracts
- Plan and control production processes, organise group work
- Set up, programme, optimise and maintain production equipment and test systems
- Assist in the analysis and optimisation of production processes
- Test and carry out routine repairs to components and devices
- Work with English language documentation and communicate in English
- · Under the provisions of the Prevention of Accidents Regulations, electronics technicians for devices and systems are deemed to be skilled electrical and electronic engineering workers.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Electronics technicians for devices and systems mainly work at medium-sized and large industrial companies which manufacture, install and maintain electronic systems, devices or components. These companies operate in such areas as vehicle electronics, medical technology, machine and plant construction and measurement and control technology.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3,5 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
