3. PROFILE OF SKILLS AND COMPETENCES

- · Accept export and import goods from different means of transport and check delivery using accompanying documentation
- · Inspect goods for quantity, quality, identity and condition and document the result
- Select containers for transport, planning, execution, checking and documentation of loading operations
- · Compile goods into loading units, unload goods into means of transport and secure goods
- Plan and organise work processes in a customer-oriented manner, assist in logistics planning and organisation processes and conduct quality assurance measures
- Storing goods in an appropriate manner and process storage goods in order to maintain their value in accordance with customer requirements
- Process dispatch and transhipment documents
- Checking, load and secure hazardous goods and apply measures to avoid risk
- Deploy equipment and means of conveyance
- · Work with a team, communicate and cooperate with upstream and downstream service providers and use knowledge of foreign languages.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Specialists in port logistics work on transit terminals and in warehouses for unit loads and bulk goods in sea and river ports.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
