- Drive buses, trams and/or underground trains on the company's network according due consideration to safety, customer satisfaction, the importance of environmental factors and economic viability
- Advise customers on fares, service connections and special offers and give information on services offered in conjunction with other providers
- Provide information in a foreign language
- Sell services, maintain required accounts and assist with calculations
- Identify customer requirements and be involved in the customer orientated development of the company's products as well as assisting with quality control
- Provide customers with information when services are operating normally and when services are disrupted
- Initiate the necessary measures in situations of danger and in the event of accidents
- Assist with planning and management of vehicles, human resources and finance
- Ensure servicing and provision of vehicles including checking roadworthiness and operational safety
- Instigate maintenance and routine repair of vehicles
- Act autonomously in performing tasks within the scope of operational instructions given and in accordance with legal stipulations
- Plan and coordinate work and reach agreement with other participants both inside and outside the company
- Work to avoid or defuse conflicts in difficult communication situations.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
