3. PROFILE OF SKILLS AND COMPETENCES

- Construct longitudinal and surface-oriented scaffolding and protective frames, support racks with sub-construction including base formwork, work decks and platforms, boat scaffolds, weather protection halls and coverings and scaffolds for special requirements
- Maintain, store and transport scaffolding components
- Assess bearing ground and ensure bearing capacity
- Anchor scaffolding, check and record anchoring
- Assemble and operate lifts and lifting platforms and instruct users
- Plan and prepare work processes
- Procure and evaluate information
- Use technical documentation
- Plan and coordinate work, set up, secure and clear construction sites
- Process materials
- Use and maintain tools, devices, machines and technical equipment
- Conduct measuring work
- Carry out quality assurance measures and draw up reports
- Operate and maintain equipment and machines
- Work autonomously either alone or predominantly in a team in conjunction with other trades to execute works on the basis of technical documentation and work orders
- Set up workplaces and initiate safety, health and safety at work and environmental protection measures
- Check the quality of the work for any errors in execution, document works
- Carry out quality assurance measures and charge for services provided.

Scaffolders find employment with scaffolding companies in the building trade and construction industry and with other companies which set up scaffolding or similar constructions.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
