3. PROFILE OF SKILLS AND COMPETENCES

- Draw up and implement plans for room and facade design
- Check and evaluate underlying surfaces and prepare such surfaces for coating
- Treat, cover, coat and design surfaces
- Apply ceiling, wall and floor coverings
- Produce lettering and signs
- Maintain and repair surfaces
- Carry out energy efficiency measures
- Carry out wood and building protection measures
- Carry out protective measures for surfaces and objects not to be treated
- Carry out finishing and installation works, carry out plastering, insulation and dry wall works
- Process materials and components
- Record materials and time used and invoice for services provided
- Implementation of measurements and documentation of results
- Select, set up, operate and maintain implements, tools, machines and equipment for the job at hand
- Erect scaffolding, operate vertical lift working platforms, set up and maintain hoists and conveyors
- Work autonomously and in a customer-oriented way to execute works on the basis of work orders, carry out planning and design works either alone or as part of a team and coordinate work with other trades
- Plan work, set up workplaces
- Stipulate stages of work steps and materials and components required and initiate safety, health and safety at work and environmental protection measures at the workplace.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Painters and varnisher specialising in design and maintenance mainly work for painting companies in the craft trades sector and for firms specialising in façade and interior design. They may also find employment with companies which carry out restoration works. They find employment on a range of different construction sites such as in the private and public sectors, in residential and commercial construction or in the industrial and plant construction sector.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body: <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
Additional information Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education. Duration of training: 3 years. Training in the "dual system": The knowledge, skills and competences delivered in a training occupation are based on the typical requirements of work processes and prepare the trainees for a specific job as well as for further qualifications. The training is provided in a company and at vocational school: Trainees spend 75% of the duration of training in the company. Here they acquire practical skills in a real working environment. Trainees complete 25% of training time in vocational school where they are taught general and vocational knowledge as it relates to their training occupation.
