- Autonomous preparation of pre-press screen print copy, import, transfer and convert data using specific hardware and software
- Make screen printing forms for a range of purposes
- Select product-specific materials, colours and production processes
- Act autonomously in setting up and operating production plants for the manufacture of screen print products
- Check and optimise the printing process in accordance with quality standards and stipulations
- Carry out measuring and testing activities as part of quality assurance
- Apply materials and product-specific post-print processing techniques
- Maintain and manage production equipment
- Work in a customer oriented manner and accord due consideration to economic and ecological aspects
- Communicate with upstream and downstream divisions for the purpose of optimisation of production processes.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Screen print media technologists work in craft trades or industrial companies in the print sector, especially in the areas of sheet-fed screen printing, web-fed screen printing, body screen printing, technical screen printing, textile screen printing, ceramic screen printing, glass screen printing, large-format digital printing and pad printing.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b>  Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
