3. PROFILE OF SKILLS AND COMPETENCES

- Cooperate in the planning and setting-up of systems and workplaces and in the procurement of
 operating resources for the technical implementation of artistic requirements, control installations and
 equipment to meet quality, safety and operational requirements; identify technical problems, arrange for
 and supervise remedial measures; arrange for and supervise the maintenance of systems and
 equipment
- Assign tasks to members of staff according to their qualifications, efficiency and suitability and taking
 artistic, technical, economic and social aspects into account; familiarize staff with their jobs and provide
 instruction; aim for partnership in relations with staff; comment and pass on suggestions and concerns
 of staff; strive for cooperation with the management and staff representation; promote the vocational
 training of staff
- Monitor costs through the needs-based, timely and cost-effective deployment of staff and resources, ensure and supervise activities, rehearsals and performances on the basis of relevant quantity, quality and artistic criteria; select suitable materials and make proper use of technical stage equipment
- Implement and supervise the necessary measures regarding occupational safety and health, accident prevention and fire safety and comply with the regulations relating to places of public assembly (*Versammlungsstätten-Verordnung*) in cooperation with the departments and persons responsible for occupational safety in the company and with relevant authorities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Certified senior event technology specialists – stage/studio, lighting, halls work as senior-level employees in private and public enterprises of different size and in different areas and operations, particularly with event agencies and organizers of congresses and trade fairs and in opera houses, theatres and concert halls. They discharge complex tasks and responsibilities related to planning, management, organization and supervision using the control instruments of business and personnel management. They coordinate the planning and preparation of events, advise their customers, draw up schemes, instruct specialist staff and assume responsibility for in-company training.

6. OFFICIALLY RECOGNIZED WAYS OF ACQUIRING THE CERTIFICATE

The certificate is acquired through passing the examination administered by the body mentioned in section 5 above. Before sitting the examination, candidates must furnish proof of

- 1. Successful completion of training for a recognized occupation in the field in which the examination is administered, followed by at least two years of practical work related to the qualifications to be obtained or
- Successful completion of training for another recognized technical or craft occupation, followed by at least six years of practical work related to the qualifications to be obtained including the training period as set out in the training regulations for the occupation or
- 3. At least five years of relevant practical work or
- 4. Relevant skills and competences.

Candidates wishing to sit the examination in the fields of lighting and halls must be skilled electricians.

Additional information

The skills and competences of which proof is to be furnished in the further training examination are usually acquired during many years of practical work and within the framework of education measures. Courses are offered in preparation for the examination; their duration and content are geared to the different specialist and managerial tasks.

The successful candidate passing the examination has acquired the qualifications required to provide training within the meaning of Section 30(5) of the Vocational Training Act.

Translations of the certificate can be obtained from the body mentioned in section 5 above.
