3. Profile of skills and competences

- · Select leather and other materials and auxiliary materials in accordance with their intended purpose, their integrity when in contact with the human body and their cost-effectiveness
- Prepare technical documentation and specify work processes
- Determine the cost of orthopaedic devices and procedures
- Draw up clinical reports on orthopaedic anomalies, attend to and counsel patients
- Measure feet and legs, create moulds, and model and produce shaped parts
- Manufacture orthopaedic footwear using a range of techniques
- Make devices to compensate for length differences and fit supporting, embedding, correcting and compensating inserts into shoes
- Correct and maintain orthopedic devices
- Carry out orthopaedic interventions on off-the-rack shoes
- Make orthoses, in particular orthopaedic inserts, inner shoes, lower leg, ankle and small-area orthoses, and foot and toe prostheses
- · Adjust ready-to-wear orthoses, in particular bandages, lower leg orthoses, foot orthoses, and compression
- Carry out medical treatment procedures on the foot
- Assess quality and initiate quality assurance measures, prepare medical indication services.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Maker of orthopaedic footwear mostly work in specialist orthopaedic footwear craft trade companies, in clinics and sanatoriums and for medical suppliers with an orthopaedic footwear department.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3,5 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
