- Evaluate and select horses which are suitable for breeding
- Plan and carrying out measures for horse breeding and breeding hygiene
- Execute measures for horse rearing
- · Train horses
- Present horses at breeding shows and examinations
- Stable management, keeping and feeding young horses and breeding horses
- Evaluate, judge, maintain and improve the health of young and breeding horses
- Supervise and instruct people
- Advise customers in a manner appropriate to the situation
- Implement sustainability in equine management
- · Plan and document work, fixing and arranging work steps and check and evaluate work results
- Carry out work independently or as part of a team and in accordance with animal protection rules, health and safety at work and health protection whilst deploying equipment, machines and operating facilities
- Consideration of cost-effectiveness aspects and assurance of quality standards when planning operational processes.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Equine managers specialising in horse breeding work at stud farms. They also find employment at stallion farms, at provincial stud farms and with companies specialising in the rearing of horses.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
