- Determine physical values, conduct optical measurements and calculate parameters, carry out optical measurements and calculate key data
- Carry out formulation and recipe calculations, test and improve recipes
- Modify product properties by controlling and regulating machines and systems
- Select resources, operating materials and auxiliary materials according to their properties, their intended use and the requirements of customers
- Produce sketches and drawings and use technical documentation
- Plan and document working steps and working procedures relating to the finishing of textile products
- Set up machines and systems, set process parameters, check finishing processes and initiate corrective measures
- Maintain machines and systems
- Carry out quality assurance measures
- Accord due consideration to ecological and environmental requirements
- Accord due consideration to the basic principles of health and safety at work and health protection.

Textile product finishers mainly work for industrial companies engaged in the textile finishing branch and are particularly employed in the fields of proofing, coating, printing and dyeing.

| <p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
