3. PROFILE OF SKILLS AND COMPETENCES

- · Work autonomously and in a customer oriented way to execute works on the basis of work orders, carry out planning works either alone or as part of a team and coordinate work with other trades
- Plan and document work, determine work steps, stipulate materials and semi-finished products required
- Record materials and time used
- Invoice for services provided, initiate safety, health and safety at work and environmental protection measures in the workplace
- Conduct discussions with customers and hand over work to customer
- Carry out quality assurance measures
- Produce shutter curtains, fabrics and shutter panels
- Make and install roller blinds and shutters, rolling doors and roller shutter and window combinations
- Install non-rolling blinds and shutters
- Install drives and control components and systems
- Carry out functional tests and maintenance and routine repair works, carry out safety and anti-burglary measures during production and installation
- Measure dimensions
- Create working documentation and use technical documentation
- Set up, secure and clear workplaces
- Erect and dismantle scaffolding, use transport equipment
- Work and process materials, ancillary materials and semi-finished products
- Use tools and operate and maintain equipment, machines and technical plants.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Roller shutters and sunshade mechatronic technicians mainly work at specialist craft trades companies in the roller shutter and blinds sector. They also find employment in the construction installation industry at companies which install windows, doors and sun protection systems. Opportunities also exist at firms which manufacture metal, wooden or plastic shutters and doors.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

Additional information

Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

Duration of training: 3 years.

Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
