- Manufacture footwear using industrial production techniques
- Select and use leather and other materials and auxiliary materials
- Stipulate work processes and use technical documentation
- Cut and press parts for shoe upper
- Prepare parts of the shoe upper
- Back-stitch and stick uppers
- Prepare parts for the base of the shoe
- Assemble uppers and base parts
- Finish footwear and prepare for sale
- Make copies of lasts
- Develop footwear models
- Assess quality and carry out quality assurance measures
- Accord due consideration to the basic principles of health and safety at work, health and environmental protection.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Footwear makers and finishers use industrial production techniques to manufacture shoes and footwear. The range of products they work with includes women's, men's and children's shoes, sports footwear, hiking boots, and professional and protective footwear. They mainly work in production and in technical departments.

| <p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
