3. PROFILE OF SKILLS AND COMPETENCES

- Prepare foot outline drawings and footstep prints, make customized inserts and foot beds for ready-to-wear shoes
- Select leather and other work and auxiliary materials in accordance with their intended purpose and cost-effectiveness
- Prepare technical documentation and specify work processes
- Cut uppers and bottoms to size
- Prepare parts of the shoe upper, particularly by splitting, skiving and folding
- Stitch uppers and linings together
- Prepare uppers and bottoms
- Join uppers and bottoms to made-to-measure shoes
- Assess quality and initiate quality assurance measures
- Use knowledge of the anatomy of the support and locomotor systems
- Support and advise customers
- Plan and prepare work processes
- Process work tasks using information and communications systems
- Work as part of a team on some tasks
- Carry out repairs.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Shoemakers work at craft trades companies specialising in shoemaking and made-to-measure footwear. They may also find employment at industrial shoemaking companies, at workshops providing fast shoe repair services or for stage workshops at theatres.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body: <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
Additional information Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education. Duration of training: 3 years. Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
