3. PROFILE OF SKILLS AND COMPETENCES

- make sails, covers, tarpaulins, marquees and awnings
- select primary and secondary materials and accessories according to their intended use and their cost-effectiveness
- plan steps in the work process and operational procedures
- prepare technical documentation
- measure and mark out areas
- handle tools and make use of plant and machines
- cut primary and secondary materials to size
- make patterns
- form stitched, welded and bonded seams
- attach accessories
- mount sails and carry out works to rigging and rigging cordage
- fit covers, tarpaulins, marquees and awnings
- carry out repair and maintenance works
- advise customers and offer services
- assess quality and take steps to implement quality assurance measures
- observe the principles of health and safety at work and environmental protection.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Sailmakers work predominantly in workshops or production shops where sails, covers, tarpaulins, marquees and awnings are manufactured. Fitting and installation work usually takes place outdoors on different sites, e.g. on ships and boats (sails, covers), on the customer's premises (awnings), at transport firms (HGV tarpaulins) and on showgrounds (marquees).

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body: <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<b>Additional information</b>  <b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education. <b>Duration of training:</b> 3 years. <b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
