- · Work autonomously and in a customer oriented way either alone or in conjunction with other trades to execute works on the basis of technical documentation and work orders
- · Plan and coordinate work
- Set up workplaces
- Set up scaffolding and initiate safety, health and safety at work and environmental protection measures
- Check the quality of the work for any errors in execution, document works
- Carry out quality assurance measures and charge for services provided
- Prepare and use technical documentation
- · Conduct measurements and document results
- · Use and maintain tools, devices, machines and technical equipment
- Use and process metals, synthetic materials and auxiliary materials
- Make structural components from natural and artificial stone
- · Lay slabs and tiles
- Install workpieces
- · Process natural stone, artificial stone and slabs
- Make components from mineral and plastic-bonded materials
- Make profiles
- Produce insert areas and inlay work
- Produce letters and symbols
- · Make and design forms, models, letters, reliefs and sculptures

# 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

#### **Additional information**

**Entry requirements:** Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

**Duration of training:** 3 years.

## Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
