3. PROFILE OF SKILLS AND COMPETENCES

- Produce and market poultry and eggs according due consideration to trade-specific regulations and quality standards
- Assist in reproducing and rearing animal stocks and produce and store hatching eggs
- Feed poultry in a correct and environmentally friendly manner according to the production line and development status
- Feed and keep poultry using farm-specific systems and methods
- Clean, disinfect and maintain animal accommodation
- Conduct preventive health measures and care for sick animals following veterinary instructions and according due consideration to hygiene specifications
- Conduct herd management measures (lighting and inoculation programmes, regulation of stall climate, stipulation of accommodation densities, placement of animals in stalls/reorganisation of stall accommodation/removal of animals from stalls and transport of poultry)
- Determine and monitor productive capacity of the animals
- Act autonomously in conducting work according to work orders or plans working both alone and as part of a team, observe basic business management and legal principles and accord due consideration to consumer and animal protection
- Utilise and dispose of residue materials (commercial dung/nutrients)
- Plan and document work, specify working steps, take measures to protect safety and health and safety at work, monitor and evaluate work results
- Carry out quality assurance measures
- Use communication and information technologies both internally within the company and when dealing with customers
- Use machines, devices and operating materials, make use of operating facilities
- Maintain and service machines, devices and operating facilities.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Animal caretakers work on livestock farms, in farming associations and institutions, in veterinary clinics and laboratories, in agricultural training institutes, in the agricultural goods trade and in farm management.

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
