## 3. PROFILE OF SKILLS AND COMPETENCES

- Maintain mechanical and electronic clocks and their component parts
- · Assemble and dismantle components and sub-assemblies
- Carry out measurements using the latest measuring techniques
- Manufacture workpieces and components using manual and machine production processes
- · Make temporary and permanent joins
- Carry out heat treatment and materials testing measures
- Treat and protect surfaces and check the form and characteristics of such surfaces
- Programme and operate numerically controlled machine tools
- · Repair jewellery which has been manufactured industrially
- · Carry out work autonomously on the basis of technical documentation and work orders
- · Sell the company's goods and products
- · Advise customers with regard to products and services and deal with complaints
- Assist in the calculation of retail prices, the preparation of offers and with servicing and sales accounting procedures
- · Assist in deciding the range of products, label and display goods
- Monitor stock, procure goods, monitor incoming goods
- · Process complaints regarding incoming goods, store and maintain goods
- Plan and coordinate work, particularly in conjunction with customers, company owners and colleagues
- Procure information
- · Initiate quality assurance measures
- · Document performance and initiate security measures, measures for health and safety at work and measures for environmental protection.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body:

- 1. after completion of dual training in a company and at part-time vocational school (normal procedure)
- 2. after retraining in a recognized training occupation
- 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions

#### **Additional information**

**Entry requirements:** Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.

**Duration of training:** 3 years.

#### Training in the "dual system":

Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. **The training is provided in a company and at part-time vocational school**: In the company, the trainees acquire practical skills in a real working environment. On one or two days per week, the trainees attend part-time vocational school, where they are taught general and vocational knowledge related to their training occupation.
