- Use mechanical, chemical and electrolytic processes for the pre- and post-treatment of uncoated and coated surfaces
- Display competence in the storage and transportation of materials and goods to be coated and in the warehousing, transport, proportioning and mixing of solid and liquid application materials
- Display competence in various application methods such as spray and application methods and electrostatic coating
- Operate, monitor and maintain technical facilities and plants, in particular by entering process parameters, modifying control programmes and documenting function and process sequences including peripheral facilities
- Display competence in the manufacturing process
- Work autonomously on tasks assigned within the work area
- Plan and coordinate work processes with upstream and downstream production processes
- Master the basic principles of mechanical processing and joining techniques
- Accord due consideration to ecological aspects in all phases of the production process
- Ensure the quality of products as part of the quality management system by using test facilities, systematic error detection and error analysis.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Final examination administered by the competent body: <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<b>Additional information</b>  <b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education. <b>Duration of training:</b> 3 years. <b>Training in the "dual system":</b> Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
