- Produce individual component parts from different materials, using tools and machines
- Programme and operate machines with numerical control
- In particular make injection moulds, press moulds, stamping moulds and punching and recasting tools
- Produce devices and operating equipment to support and/or extend industrial production facilities
- Assemble structural parts and sub-assemblies to produce tools, instruments, devices or moulds
- Make mould surfaces using fine machining techniques
- Carry out routine repairs
- Check and optimise functions and processes in terms of quantity and quality
- Use technical documentation and information and communication systems including in the English language
- Plan and control working procedures
- work as part of a team
- check, evaluate and document work results and make use of quality assurance methods.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Tools mechanics mainly work in industrial companies in the fields of moulding, instrument, stamping and appliance technology. They particularly find employment in the industrial series manufacture of products made of synthetic materials and metals as well as in the manufacture of surgical instruments.

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3,5 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
