- Manufacture and repair plucked musical instruments such as historical harps, folk harps and concert harps
- Develop and create designs
- Process wood, metals, plastics and other materials manually and by machine
- Join and connect components
- Assemble the components of plucked musical instruments, e.g. body, neck, columns and actions
- Treat and varnish surfaces
- Install pick-up systems
- Assemble instruments ready for use and carry out quality checks
- Identify different instruments and distinguish between various methods of construction and acoustic concept
- Advise and look after customers
- Prepare, read and use sketches, drawings and technical documentation
- Set up workplaces
- Use, maintain and manage tools and machines
- Monitor and optimise work processes
- Assess quality and carry out quality assurance measures
- Accord due consideration to health and safety at work, environmental protection and the rational use of energy.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Makers of plucked musical instruments mainly work for small and medium sized companies manufacturing stringed and plucked instruments. They also find employment with companies which repair plucked musical instruments.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
