3. PROFILE OF SKILLS AND COMPETENCES

- Manufacture, repair and restore stringed instruments
- Process wood, plastic, metal and other materials manually and by machine
- Join components, in particular by pasting and gluing
- Assemble the components of plucked musical instruments, e.g. body, neck and finger board, and string such instruments
- Treat and varnish surfaces
- Assemble instruments ready for use, tune instruments and carry out final functional and optical checks
- Identify different instruments and distinguish between various methods of construction and acoustic concept
- Prepare, read and evaluate sketches, parts lists and drawings
- Set up a workplace at a bench or a machine tool
- Use, maintain and manage tools and machines
- Accord due consideration to health and safety at work, environmental protection and the rational use of energy.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Maker of plucked musical instruments mainly work for small and medium sized companies making stringed and plucked instruments. They also find employment with craft trade companies which repair plucked musical instruments.

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> <li>1. after completion of dual training in a company and at part-time vocational school (normal procedure)</li> <li>2. after retraining in a recognized training occupation</li> <li>3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions</li> </ol>
<p><b>Additional information</b></p> <p><b>Entry requirements:</b> Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p><b>Duration of training:</b> 3 years.</p> <p><b>Training in the "dual system":</b>  Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. <b>The training is provided in a company and at part-time vocational school:</b> In the company, the trainees acquire practical skills in a real working environment.
